every resolution must have a title whereas clause s and resolved clause s and must carry the author s name s the title should convey the general idea of the topic of the resolution the whereas clause s should explain the rationale for the resolution

format the title of the resolution must appropriately reflect the intent resolutions begin with whereas statements which provides the basic facts and reasons for the resolution and conclude with resolved statements which identifies the specific proposal for the requestor s course of action whereas statements
