as of january 2023 14 states have outlawed or severely restricted abortion 1 morbidity and mortality around the time of labor is already on the rise nationally from 658 in 2018 to 861 in 2020 2 particularly in places where abortion is restricted and labor care is increasingly sparse because of loss of the workforce after the covid 19 pandemi
