german administrative law between 1981 and 1982 dr singh spent nearly two years in heidelberg doing re search partly at the south asia institute of the ruprecht karl university and partly at the max and admirable manner and he has now completed the present book which is based on his studies in heidelberg for several reasons dr singh is especially qualified to write this book his famil iarity with
