as being in good shape this study aims to determine whether companies announcing to the public that they will pay dividends will cause abnormal returns in the stocks of the relevant companies in other words the impact of companies decision to distribute dividends on the value of the relevant companies was investigated according to the efficient markets hypothesis in semi strong form efficient markets firms cannot obtain abnormal returns on their stocks with any information they disclose to the public with this study it will be determined how the company value is affected when companies dividend distribution decisions are announced to the public moreover it will be revealed to what extent the capital market in turkey is effective in semi strong form
