of relentless investigation decorated miami beach homicide detective joe matthews finally identified adam s killer bringing adam home is the definitive account of this horrifying crime as harrowing as in cold blood yet ultimately uplifting bringing adam home is the riveting story of a triumph of justice and the enduring power of love
